**1.1 General Requirements**

- Technology: 3LCD laser projector
- Application: Professional / installation-grade
- Light Source: Laser diode or better suitable
- Light Source Lifetime: Minimum 20,000 h/30,000 hours (max brightness/ECO)
- Installation Type: Ceiling mounted
- Continuous operation capability suitable for professional environments

- iii. If any claim made or information provided by the bidder in the bid or any information provided by the bidder in response to any subsequent query by Embassy of India Budapest, is found to be incorrect or misinterpretation of facts, then the bid will be liable for rejection.
- iv. After the selection, the successful bidder must be able to commence the service within 7 days after the award of Letter of Intent.
