# 2. Important India related statements of commercial significance by political leaders, think tanks, chambers, associations etc:

### Visit of the AEPC delegation 21-24 March 2018

- On 22<sup>nd</sup> March a meeting took place in the National Trading House of Hungary. Mr. Laszló Süveges Director of Asia Project directorate emphasized that India offers huge opportunities to the Hungarian companies and that the Trading House is planning multiple forums/roadshows to increase awareness to Hungarian companies.
- On 23<sup>rd</sup> March a visit to the Hungarian Investment Promotion Agency was made. Vice-President of HIPA, Mrs. Tünde Kis highlighted the flagship industries of Hungary (automotive, service, pharma) and informed that textile industry is not a core industry anymore due to the competition from the East. She also highlighted the importance of the signing of MoU between Invest India and Hungarian Investment Promotion Agency at the 5th India-Hungary Joint Commission on Economic Cooperation held on 5-6th March in New Delhi aimed at supporting investment concepts and investment promotion projects, and the joint realization of investment promotion programs and events

### Visit of the IIPA delegation to Hungary on March 19-25, 2018

- On 20 March the delegation called on the Deputy Speaker of the Parliament, H.E. Mr. István Jakab who emphasized the importance of deepening the bilateral relationship between the two countries.
- The delegation also met President of Indo-Hungarian Parliamentary Friendship group in the Parliament H.E Mr. Peter Cseresnyés, who emphasized the importance of India in the bilateral relations with Hungary and noted the biggest recent investment (EUR 475) by India, by Apollo Tyres. The factory was inaugurated on 7th April 2017.

• On 23rd March, the delegation called on Mr. Kannan Prabhakar, Managing Director of Apollo Tyres factory in Gyöngyöshalasz. During the meeting he conveyed to the delegation that Apollo chose Hungary for its investment because of its strategic location with good infrastructure and well-trained competitively-priced workforce.

### Visit of IIPA Delegation:

A 23-member delegation from the Indian Institute of Public Administration (*IIPA*) visited Hungary as part of their study tour on March 19-25, 2018. The delegation consisted of 2 foreign participants - one each from Sri Lanka and from Mauritius.

2. As part of their working visit, the delegation called on Ambassador on 20 March at the Embassy. Thereafter, delegation proceeded to visit the Hungarian Parliament where they met with Mr. Péter Cseresnyés, State Secretary for Labour Market and Training at the Ministry for National Economy, and President of the *Indo-Hungarian Parliamentary Friendship Society*. They also met with Mr. Istvan Jakab Deputy Speaker of the National Assembly and also took a guided tour of the Hungarian Parliament building. The delegation then proceeded to the Budapest Mayor's Office where they were given a presentation on the working on the local government. The visit for the day was wrapped up by the meeting at the Ministry of Foreign Affairs and Trade where the delegation was given a presentation by Dr. Csaba Balogh Minister of State for Public Administration, Dr. Sándor Sipos Director General for Asia Pacific and Mr. Ferenc Jári Director, Department of the Asia-Pacific.

3. The delegation visited the Hungarian Development Bank the next day (*March* 21); undertook visit to Historical and Heritage sights in Budapest and visited the main agricultural area of Hungary, City of Villány.

4. Other meetings of the delegation comprised of visits to National University of Public Service; National Health Insurance Fund; Wastewater Treatment Plant; visit to Apollo Tyres plants in Gyöngyöshalász and the visit to Institute for Foreign Affairs and Trade.

Apollo Tyres had conveyed to the delegation that it chose Hungary for its investment because of its strategic location with good infrastructure and well-trained competitively-priced workforce.

5. Ambassador, in association with Bharatiya Samaj of Hungary, also hosted a dinner for the delegation on March 22, 2018.

6. The delegation appreciated the help given by the Mission in organizing the valuable meetings, which greatly contributed to the quality of their educational visit to Hungary.

### Visit of AEPC delegation:

A 4-member delegation led by Mr. H K L Magu, Chairman, Apparel Export Promotion Council (*AEPC*) visited Hungary on 21-24 March 2018. AEPC, an apex body of apparel exporters visited Hungary with an objective of exploring apparel export and marketing opportunities. The delegation visited Hungarian Chamber of Commerce and Industry, TMTE (Hungarian Society of Textile Technology and Science), Budapest Chamber of Commerce and Industry and the National Trading House of Hungary on their first day of engagement on March 22.

2. On March 23, the delegation visited Hungarian Investment Promotion Agency and had a luncheon meeting with Dr. Amar Sinha, President of India-Hungary Business Association. They also undertook visit to an Indian owned store Exotic India and devi textiles.

3. The delegation also attended a dinner hosted by Ambassador, in association with Bharatiya Samaj of Hungary, on March 22.

4. The AEPC delegation informed the Mission that there is little scope for textiles on the very limited Hungarian market.

### Megasoft Solutions India planning expansion to Hungary:

Embassy of India, Budapest has been visited recently by Mr. Sandor Söpkéz Managing Partner of EastEuroCo Executive Search Group. EastEuroCo is representing Megasoft Solutions, an IT based HRMS service and payroll management service provider powerhouse headquatered in Gurgaon. Megasoft Solutions has a strong foothold across globe including Singapore, Dubai, Hong-Kong, and Germany.The companies are working together to make expansion to Hungary and the whole CEE region.

### SRF Ltd exploring investment to Hungary

Prashant Mehra, President & CEO and Mr. Ashish Bharat Ram, Manging Director visited the Embassy of India and informed that the flexible packaging company SRF Ltd is exploring the possibility of investment to Hungary. The company is located in Gurgaon, Haryana and is producing techical textiles, fabrics, specialty chemicals, engineering plastics, and packaging films.

The Hungarian Side informed that the recent legislation on the Prevention and Combating of Money Laundering and Terrorist Financing adopted by the Hungarian National Assembly on 16 May 2017 effectively closed all loopholes used by fraudsters

### 8. Any Other Issue of Importance:

**European Commission sees shortcomings in governance:** The European Commission both praised and criticized Hungary in its latest country report. The country's strong 2017 GDP growth exceeded potential, but the economic recovery provides a window of opportunity for Hungary to ensure sustainable growth in the coming decade, it said. The country's economic vulnerability has lessened, employment levels reached record highs and lending has expanded while banks have returned to profitability, the commission noted. But Hungary has not completed the recommendations made in, such as simplifying the tax system, cutting taxes for low- income earners, improving public procurement regulations and curbing corruption. "Weaknesses in institutional soundness and governance could weigh on the country's economic convergence. Limited transparency and quality of policy making is a source of uncertainty for investors," the commission said. Furthermore, "the education and health-care systems reveal shortcomings in fostering the development of human capital. Education outcomes in basic skills are significantly below the EU average," it warned.

**Fitch affirms Hungary's rating:** Credit-rating agency Fitch on Friday maintained its outlook for Hungary's long-term foreign- and local-currency issuer default ratings at "BBB-" with a positive outlook, in line with analysts forecasts. This follows a similar move by rival agency Standard & Poor's in February. In its latest analysis, Fitch said Hungary's rating balances strong structural indicators against relatively higher public and net external debt, a higher level of policy unpredictability and macroeconomic volatility.

**MNB raises growth forecasts:** The MNB has raised its 2018 GDP growth forecast from the 3.9% envisaged three months ago to 4.2% and its 2019 projection from 3.2% to 3.3% in its quarterly inflation report. The report expects that through the expansion of domestic consumption and the arrival of EU funds would accelerate GDP growth in 2018.

Vehicle sector closes record year: Hungary's vehicle industry closed 2017 with a record output worth Ft 8 trillion (appx €25.6 bln), Development Ministry State Secretary Robert Homolya said. The sector's output rose 10% year-on-year in January. Companies in the vehicle industry employ some 175,000 people.

**Budget deficit soars in February:** The budget deficit totalled a massive Ft 333.8 billion (appx € 1.1 bln) in February, pushing the budget short-fall of the first two months of this year to Ft 526.6 billion (appx € 1.7 bln), data the Economy Ministry showed. The cumulative January-February deficit is nearly 40% of the Ft 1.361 trillion (appx € 4.4 bln) year-end target. The budget is stable

and the massive increase was due to large advance payments related to EU support, financed from the budget, the ministry said. The rise is also due to spending picking up on developments the government had pledged to several large towns, the ministry underlined.

**Inflation slows down:** February inflation was 1.9% on the year, down from 2.1% in January, the Central Statistics Office announced. Core inflation was 0.2% on the month and 2.4% on the year in February. In the first two months of the year, inflation was 2.0% versus the same period of 2017.

**Average 12-month pay rise near 14%:** The average gross wage was Ft 310,800 (€ 995) a month in January, up 13.8% year-on-year, but down from Ft 327,700 (€ 1049) in December, the Central Statistics Office announced. The average gross wage was Ft 323,000 (€ 1034) in the private sector, Ft 289,000 (€925) in the public sector and Ft 265,800 (€ 850€) at NGOs.

**OECD:** Hungarian wages lowest in Eastern Europe: The average net wage in Hungary calculated on the basis of purchasing power parity in dollars is slightly below \$22,000 a year, the lowest among Eastern-European countries, according to a fresh OECD survey. The net wage is slightly over \$22,000 a year in Latvia, it almost reaches \$23,000 in Lithuania and \$23,500 in Slovakia, to list some of the lowest, it added.

**Construction expansion continues:** The output of Hungary's construction industry soared by 43.2% year-on-year in January, up from 35% growth in December, beating estimates, according to preliminary data from the Central Statistics Office. On a monthly basis, output grew by 6.4%.

**January industrial growth confirmed:** Hungary's industrial output increased 6.9% year-on-year in January, rebounding from a 0.5% year-on-year drop in December, according to the Central Statistics Office. Working-day adjusted data show output up 6.7%. Growth in pharmaceutical, rubber, metal products and wood product manufacturing was up by double digits. The production of transport equipment – accounting for 29% of manufacturing output – was 5.2% higher year-on-year. The manufacture of parts and accessories for motor vehicles went up 10.5%, whereas the manufacture of motor vehicles saw a 0.9% drop.

**Foreign trade expanded in January:** The January trade surplus came to €676 million, up from €563 million in the same month of 2017, according to preliminary figures from the Central Statistics Office. Exports went up 10% to €8.5 billion, while imports were 9.3% higher at €7.8 billion, as growth in exports outpaced that in imports for the second time in 13 months. EU countries took in 80% of Hungary's exports and provided 74% of imports. Hungary's exports rose to a record €100.6 billion in 2017. As imports grew 8.2% to €92.5 billion, the trade surplus narrowed to €8.1 billion in 2017 from the all-time high of €9.7 billion in 2016.

ThyssenKrupp opens Ft 33.5bn factory: Germany-based automotive supplier ThyssenKrupp opened a new plant in Jászfé-nyszaru at a cost of Ft 33.5 billion (appx € 107.2). ThyssenKrupp will manufacture overhead camshafts and electro-mechanical power steering at the new unit. The greenfield investment will create 500 new jobs by 2019, ThyssenKrupp Component Technology Hungary CEO Marc de Bastos Eckstein said. The company employs some 1,000 workers at its plants in Hungary. It assembles chassis at its Győr plant for Audi and has a coil spring and stabilizer facility in Debrecen. It operates a software development centre for steering transmissions in Budapest.

### 8. Any Other Issue of Importance:

**€5 Million for Energy Efficiency in Bosnia:** The EBRD is providing a loan of up to €5 million to MKF Partner, a microfinance institution in Bosnia and Herzegovina, to support urgently needed energy efficiency investments in the country's residential sector. The finance is provided under the Bank's €85 million Green Economy Financing Facility (GEFF) for the Western Balkans. Incentives and technical cooperation in support of green technology investments will be provided by the European Union (EU), Austrian Federal Ministry of Finance and the European Western Balkans Joint Fund under the Western Balkans Investment Framework. The funds will be on-lent to individuals, residents' associations, producers, service providers, suppliers and vendors of green technologies for investments that modernise existing housing stock and support the implementation of sustainable energy technologies.

**ArcelorMittal Invests \$47 Million to Overhaul Plant, Curb Pollution:** ArcelorMittal, the world's largest steelmaker, said it was investing 75 million KM to overhaul a blast furnace at its steel plant in Bosnia to extend its lifespan and improve environmental standards. Environmentalists have long complained about high levels of pollution caused by the plant in the central Bosnia town of Zenica, which has a workforce of 2,200 people and is Bosnia's top exporter. Work will start on what will be the biggest overhaul at the plant since 1989 and should extend the lifespan of the plant for another 15 to 20 years, Dijana Bozic-Srdanovic, the plant's spokeswoman, said. The work should be completed by the end of June, she said. The steelmaker was installing three filters at the facility which are designed to capture 95 percent of harmful gases and reduce dust emissions to less than 10 milligrams per normal cubic meter, said Bozic-Srdanovic.

**Trade Gap Narrows Slightly, exports grow by 17.7%:** Bosnia's trade deficit edged down 1.1% on the year in the first two months of 2018, reaching 856 million KM (437.7 million euro), the national statistics office said. Exports rose 17.7% year-on-year to 1.8 billion KM in the January-February period, while imports increased 10.9% to 2.7 billion KM, the Agency for Statistics said in a statement. In 2017, Bosnia's trade gap increased 5.0% reaching 7.081 billion KM.

**Central Bank Net Foreign Exchange Reserves Rise in January:** The net foreign exchange reserves held by the Central Bank of Bosnia and Herzegovina grew 1.3% on the month to 10.7 billion KM (5.5 billion euro) at the end of January, official figures show. At the end of January 2017, the bank's net foreign exchange reserves totaled 9.4 billion KM, according to data posted on the Central Bank's website.
