Analysis: In the period of January to November 2018, in USD terms, exports to India increased by 24.2% while imports from India grew by 3.2%. Balance of trade is in India's favour in value of USD 174.7 mln. In EUR terms, exports to India increased by 16.9%, while imports from India fell back by 3.2%, resulting in a balance of trade in India's favour in value of EUR 146.7 mln.

FM Peter Szijjártó reports on record year for FDI: Large foreign direct investments in Hungary assisted by the government's promotion programme brought Ft 1.380 trillion (appx € 4.3 bln) into the country in 2018, Foreign Affairs and Trade Minister Péter Szijjártó announced. The government provided Ft 135 billion (appx € 422 mln) in subsidies for these 98 projects, he added. Szijjártó highlighted that 2018 was the most successful year to date in terms of the number of foreign investment projects and their total value. These investments created 17,024 jobs with an average monthly wage of Ft 425,700 (appx € 1330), he noted. German companies led the way with 28 projects, investing Ft 620 billion (appx € 1.9 bln) in total. US companies carried out 15 large projects, while 17 came from South Korea, Japan, China and India.







# ANALYSIS OF TRADE QUERIES RECEIVED







### **Any Other Issue of Importance:**

- 1. World Bank growth forecast well below government figure: The World Bank has left its Hungarian economic growth forecast for 2019 unchanged at 3.2% in its latest semiannual report, far below the government's 4.1% projection. The Washington-based institution raised its estimate for GDP growth in 2018 from 4.1% to 4.6%. Hungary's GDP expanded 4.8% year-on-year in the first nine months. The World Bank lowered its forecast for Hungary's GDP growth in 2020 to 2.8% from 2.6%. It puts the 2021 growth rate at 2.4%. In contrast to the decelerating global growth, economic output in Hungary can remain strong, the Finance Ministry said. Expansions in consumption, market services and investments can guarantee a growth rate above 4% in the coming years, it added.
- 2. International reserves at 33-month high: The central bank's foreign reserves stood at €27.4 billion at the end of December, the highest figure in 33 months, the MNB announced. The reserves grew by €2.7 billion in December, lifted by a 2 billion-yuan (appx EUR 25.6 mln) bond issue and the influx of €1.7 billion in EU development funds. Foreign reserves were up €4.03 billion from the end of 2017. Gold reserves rose by €1.1 billion after the MNB increased its gold holdings in 2018 from 3 tonnes to 31.5 tonnes.
- 3. FM Szijjártó opens export partner scheme: Foreign Affairs and Trade Minister Péter Szijjártó announced the signing of a cooperation agreement with nine Hungarian-owned companies which significantly contribute to exports. He told a press conference that companies involved in the priority exporter programme KEPP will enjoy priority in accessing the state's export promotion services, and will be consulted on export-related measures. The nine companies are: 77th

Elektronika Műszeripari, ANY Biztonsági Nyomda, ARH Informatika, Csaba Metál Öntödei, Graboplast Padlógyártó, the KÉSZ Group, Master Good, Mediso Medical Imaging Systems and Naturtex Gyapjú- és Tollfeldolgozó. These companies exported Ft 120 billion (appx € 375 mln) worth of goods and services in 2017, up by 63% from three years earlier, FM Szijjártó highlighted.

ArcelorMittal's Bid to Buy Stake in Iron Ore Mine Rejected: ArcelorMittal's application to bid for the Bosnian government's stake in the Ljubija iron ore mine has been rejected over procedural issues. ArcelorMittal owns a steel plant in the central Bosnian town of Zenica where it processes iron ore from its mines in Prijedor in the north of the country. ArcelorMittal Group expressed an interest in buying the government's shares through its ArcelorMittal Holdings AG division, 51 percent owner of its local subsidiary ArcelorMittal Prijedor, which has exclusive exploitation rights in the mines under a previous agreement with the government. The company expressed its disappointment with the decision, and said the decision also jeopardizes the long-term future of mining in the Prijedor area. An official at the Investment and Development Bank (IDBRS) said that ArcelorMittal Holdings AG did not meet the required criteria and that a new auction of the government stake would be announced soon.

**341.9** mIn Euro of foreign investments in BiH for the nine months **2018**: According to the preliminary data published by the Central Bank of BH, foreign direct investments for the first nine months of 2018 amount to BAM 668.6 million (EUR 341.9 million), thus reaching a slight increase by 0, 1% compared to 2017), but also maintained a trend of increase by 21.6% compared to the five-year average of foreign investments. The largest amount of investments in 2018 came from Switzerland, Austria, Turkey, Great Britain, United Arab Emirates, Kuwait and the Russian Federation. The Director of the Foreign Investment Promotion Agency of BiH (FIPA) Gordan Milinić emphasized that,

considering the election year 2018 and an unstable political situation that was a dominant topic in all talks with potential foreign investors, this is a very good result.

Concession for Construction and User of HPP Foca and Paunci for cost of EUR 245
 Million: The construction of the hydropower plant Foca on Drina River, with an installed

capacity of 44.15 MW and an estimated annual production of 175.8 Gwh, is expected to amount to KM 232.7 mln (€ 119 mln). The concession will be awarded through a negotiated procedure, based on the offer of the Public Enterprise of the Elektroprivreda RS Trebinje. The planned location of the HPP Foca dam is about 1.6 km upstream from the city of Foca and about 10 kilometers downstream from the location of the Buk Bijela dam. The Entity Government has also issued a decision on determining the conditions for granting a concession through a negotiating procedure for the construction and use of HPP Paunci on the Drina River, of the installed power of 43.21 MW and an estimated annual output of 166.9 GWh. HE Paunci is located about 10 km downstream of the dam of HPP Foca. The total value of the investment for realization of the concession in question, however, according to the feasibility study, is KM 246.4 mln (126 mln).

# **Any Other Issue of Importance:**

- 1. Earlier 2019 Growth Projections Confirmed at 3.4%: The World Bank has confirmed the earlier projections for Bosnia and Herzegovina's economic growth for 2019, at 3.4 percent. This international financial institution expects the BiH economy to accelerate its growth to 3.9 percent in 2020, and to 4.0 percent in 2021.
- 2. Sarajevo Airport finishes record year, anticipates further growth in 2019: Sarajevo Airport anticipates another successful year in 2019 as it continues work on its terminal expansion and prepares to welcome new carriers. It comes following a record 2018 during which it handled 1.046.635 travellers, marking the first time it has managed to surpass the one million passenger mark in a single year. The figure represents overall growth of 9.3% on 2017, or an additional 88.937 travellers.
